IN ALL CASES AND AT SUCH TIME AS REFUNDS ARE APPLICABLE, THE MEMBER OR SUCH MEMBER'S DESIGNEE WHO IS ENTITLED TO A REFUND SHALL BE OBLIGATED TO GIVE THE BELLEVUE CLUB WRITTEN NOTICE OF SUCH MEMBER'S OR DESIGNEE'S THEN CURRENT ADDRESS AND UNLESS AND UNTIL SUCH WRITTEN NOTICE IS GIVEN TO THE BELLEVUE CLUB REQUESTING A REFUND WITHIN 30 DAYS OF REFUND DATE, THERE SHALL BE NO OBLIGATION ON THE PART OF BELLEVUE CLUB TO MAKE SUCH REFUND.

BELLEVUE CLUB SENIOR DESIGNATE MEMBERSHIP APPLICATION AND TRANSFER

1. Membership Classification

I understand that all membership classifications, qualifications for membership in each classification and respective initiation fees and dues charges have been presented to me with this application. I understand that dues and other charges are subject to periodic adjustment.

2. Fitness Equipment and Services

I understand that the Bellevue Club (or Club) provides a variety of exercise equipment to include: free weights, weight machines and other body strengthening machines. The equipment may change from time to time at the discretion of the Club. Private training, fitness classes and spa services are available at additional fees obtainable at the Athletic Desk and outlined in the Club magazine, *REFLECTIONS*. Classes offered and fees charged are changed periodically. The facilities include steam and sauna in the adult locker rooms and a coed jacuzzi in the pool area. I assume responsibility for checking current classes and fees.

3. APPLICANT'S RIGHT TO CANCEL

I understand that as a Designee Member, if I wish to cancel this Agreement, I may do so by delivering or mailing a written notice to the Bellevue Club 11200 SE 6th Street Bellevue WA 98004. Upon receipt of the notice, the Designee's membership will be cancelled and the membership returned to the Designor. If the Designor is under the age of 72, the membership will revert to a Family or Single classification as the case may be. The initiation deposit under this Section 3 shall revert to the Designor for refund at the end of 40 years from the Designor's original date of joining the Bellevue Club.

4. Death or Total Disability

I understand that if I die or become totally disabled within three years of this agreement, the Bellevue Club will revert the Senior Designate membership to the Designor. If the designor is under the age of 72, the membership will revert back to Family or Single classification. The initiation deposit will be reinstated to the Designor for refund at the end of 40 years from the Designor's original join date.

5. Membership Card

I understand that a membership card will be issued to each qualified person on the membership. I understand that I must scan/show my card each time upon entering the Club. I understand that the membership cards are the property of the Bellevue Club and upon termination of membership for any reason I shall return all membership cards issued under my membership.

6. No Assessments, Assumption of Liability or Ownership

I understand and agree that I can never be assessed for any liability of the Club, that I am assuming no liability whatsoever in connection with this membership other than the payment of the required initiation deposit, the applicable membership dues and charges incurred by me, my family and guests in the use of the Club, and that this membership does not confer upon me any interest in the income of the Club or any ownership of the Club property or assets.

7. Initiation Deposit

I understand that the initiation deposit is a nonrecourse, non-interest bearing obligation, repayable solely from the assets of the Club. Such initiation deposit will also serve as a security deposit to guarantee the payment of all dues and charges applicable to this membership. I understand that I may resign from the Club by giving 30 days advance written notice to the Club and by paying any dues or other charges for which I may be liable and I shall not thereafter

be subject to any further dues or other charges; it being further agreed, however, that I may not offset dues and charges against the initiation deposit.

I understand that if there is no cancellation of a Designee's Membership pursuant to previous Paragraph 3, the initiation deposit will be deemed transferred to the Designee by Designor and the Designor shall not be entitled to any portion of a initiation deposit refund, however the Designee shall only be entitled to a refund upon giving the notice required under Paragraph 3 and such initial refund shall only become applicable 40 years from the date of the transfer from Designor to Designee set forth in this Agreement.

8. Senior Designate Membership

I understand that this membership is not transferable by me to another individual and may not be changed to a Corporate membership.

9. WAIVER OF LIABILITY

I understand that in consideration of the Membership Rights granted hereunder, the member accepts the Club's services and facilities "as is" and agrees that all use of the Club's services and facilities shall be undertaken at the member's sole risk.

I understand there is risk involved in physical activities and I, as a Club member, shall not hold the Club liable for any injuries or damage to my person or property, or that of my family or guests, arising out of the use of the Club's services or facilities, whether or not resulting from acts of active or passive negligence on the part of the Club, its officers or agents. I, as a Club member, personally and on behalf of my executors, administrators, successors and assigns expressly forever release and discharge the Club, its successors, assigns, officers and agents from all claims, demands, actions or causes of action and Club attorney's fees and costs relating to any such injuries or damages. I further understand that the Club shall not be responsible for any of my property, or the property of my family or guests, which is lost or stolen in the Club.
