In consideration of the return of a partial refund of my initiation deposit, I, the undersigned terminating member hereby acknowledge and agree that I am relinquishing the remaining portion of my initiation deposit. I also acknowledge that the initiation deposit being refunded is a non-recourse, non-interest bearing obligation and the Club has no further liability to the member. **Any member who joined the Club after Dec. 31, 1986, and prior to June 1, 2009, is entitled to a full refund of their initiation deposit only 30 years from the date they joined the Club. Any member who joined the Club after June 1, 2009, is entitled to a full refund of their initiation deposit only 40 years from the date they joined the Club**

UNLESS SUCH WRITTEN NOTICE IS GIVEN TO THE BELLEVUE CLUB REQUESTING A REFUND WITHIN 30 DAYS OF REFUND DATE THERE SHALL BE NO OBLIGATION ON THE PART OF THE BELLEVUE CLUB TO MAKE SUCH REFUND.**
