# BELLEVUE CLUB MEMBERSHIP AGREEMENT

## 1. Membership Classification

All membership classifications, qualifications for membership in each classification and respective initiation deposits and dues charges have been presented to me with this application. I understand that dues and other charges are subject to periodic adjustment.

## 2. Fitness Equipment and Services

The Bellevue Club (or Club) provides a variety of exercise equipment to include: free weights, weight machines and other body strengthening machines. The equipment may change from time to time at the discretion of the Club. Private training, fitness classes and spa services are available at additional fees obtainable at the Athletic Desk, outlined in the Club magazine, *REFLECTIONS*, and on the Bellevue Club Web site at [www.bellevueclub.com](http://www.bellevueclub.com). Classes offered and fees charged are changed periodically. The facilities include steam and sauna in the adult locker rooms and a coed jacuzzi in the pool area. I assume responsibility for checking current classes and fees.

## 3. APPLICANT'S RIGHT TO CANCEL

I understand that I have the option to cancel this agreement without penalty by delivering or mailing a written notice stating that I wish to cancel my membership to the Bellevue Club, 11200 S.E. Sixth St., Bellevue, WA 98004, within 30 days of this agreement. If I cancel this agreement within the 30 day period, the Bellevue Club will return my initiation deposit, less any charges incurred (including 30 days dues) to my account within 30 days from the date of delivery to the Bellevue Club of my notice of cancellation. I understand that if I incur charges in excess of my initiation deposit, that I will be liable to the Bellevue Club for such excess together with interest of 18 percent.

## 4. Membership Privilege - Involuntary Termination or Suspension

I understand that membership is a privilege. Membership may be involuntarily terminated for violations of the Club's rules or policies, as well as conduct that is deemed offensive, inappropriate or prejudicial to the best interest of the Club and its membership. Non-payment of dues or other indebtedness will result in a suspension or termination of membership. Notice of suspension or termination shall be given to the member and a hearing may be granted at the discretion of the Club to examine matters.

## 5. Death or Total Disability

I understand that if I die or become totally disabled within three years of this agreement, the Bellevue Club will issue a prorated refund of the initiation deposit less 50 percent; any applicable refund shall be made within 30 days from date of notification to the Club. Total disability must be confirmed in writing by an examination of a physician agreeable to me and the Club.

## 6. Membership Card

A membership card will be issued to each qualified person on the membership. I understand that I must scan/show my card each time upon entering the Club. I understand that the membership cards are the property of the Bellevue Club and upon termination of membership for any reason I shall return all cards issued under my membership.

## 7. No Assessments, Assumption of Liability or Ownership

I understand and agree that I can never be assessed for any liability of the Club, that I am assuming no liability whatsoever in connection with this membership other than the payment of the required initiation deposit, the applicable membership dues and charges incurred by me, my family and guests in the use of the Club, and that this membership does not confer upon me any interest in the income of the Club or any ownership of the Club property or assets.

## 8. Initiation Deposit

I understand that the initiation deposit is a nonrecourse, non-interest bearing obligation, repayable solely from the assets of the Club. Such initiation deposit will also serve as a security deposit to guarantee the payment of all dues and charges applicable to this membership. I understand that I may resign from the Club by giving 30 days advance written notice to the Club and by paying any dues or other charges for which I may be liable and I shall not thereafter be subject to any further dues or other charges; it being further agreed, however, that I may not offset dues and charges against the initiation deposit.

Notwithstanding anything to the contrary in this document, in all cases at at such time as refunds are applicable, the member, terminated member or such member's designee who is entitled to a refund shall be obligated to give the Bellevue Club written notice of such member's or designee's then-current address. Unless such written notice is given to the Bellevue Club requesting a refund within 30 days of refund date there shall be no obligation on the part of the Bellevue Club to make such a refund.

## 9. Athletic Membership

I understand that Family and Single Athletic memberships are not transferable, except by a Senior Designate Transfer. I understand and agree that I am entitled to the repayment of my entire initiation deposit 40 years from the date of full payment of my Athletic initiation deposit, except if I participate in the Senior Designate Transfer, in which case, the assignee will receive the initiation deposit refund at the end of 40 years from the date of transfer.

## 10. Corporate Athletic and Corporate Additional Designate Athletic Memberships

I understand that Corporate Athletic and Corporate Additional Designate Athletic Memberships are held by the applicant business firm and shall be designated only to employees of the firm. When a designate of the membership is no longer employed by the firm he/she no longer is entitled to membership privileges at the Bellevue Club. It is the responsibility of the business firm to notify the Club to cancel the designated member. A Corporate membership may be reassigned to another employee within the firm by submitting a written notice to the Club and payment of a \$150 transfer fee. It is understood and agreed that the firm is entitled to the repayment of the initiation deposit of the Corporate Athletic and Corporate Additional Designate Athletic memberships 40 years from the join date unless that membership is transferred to another employee, in which case, the initiation deposit is refunded to the firm 40 years from the date of the most recent transfer, and only if the prime designate is still a member of the Club.

## 11. Social and Professional Membership

I understand and agree that Social and Professional memberships are only for use of the social facilities and social programs of the Club; all athletic facilities and athletic programs are restricted. I further understand that only the member and spouse may utilize these facilities; children are not included in either membership. Violation in use of membership will result in immediate suspension of membership. Social and Professional memberships are not transferable. I understand and agree that I am only entitled to the repayment of my entire Social initiation deposit if 40 years from the date of full payment of my initiation deposit, I am still a member of the Club.

## 12. Waiver of Liability

In consideration of the Membership Rights granted hereunder, the member accepts the Club's services and facilities "as is" and agrees that all use of the Club's services and facilities shall be undertaken at the member's sole risk. I understand there is risk involved in physical activities and I, as a Club member, shall not hold the Club liable for any injuries or damage to my person or property, or that of my family or guests, arising out of the use of the Club's services or facilities, whether or not resulting from acts of active or passive negligence on the part of the Club, its officers or agents. I, as a Club member, personally and on behalf of my executors, administrators, successors and assigns expressly forever release and discharge the Club, its successors, assigns, officers and agents from all claims, demands, actions or causes of action and Club attorney's fees and costs relating to any such injuries or damages. I further understand that the Club shall not be responsible for any of my property, or the property of my family or guests, which is lost or stolen in the Club.
